I am directed to state that the proposal of the Loyala Institute of Business Administration, Madras was considered by All India Board of Management Studies of the Advisory All India Council for Technical Education at its meeting held The proposal was not approved by the All India 30.10.1986. Board as it lacked computer facilities and core staff. institute informed the statutory AICTE that it has complied with the observations of the All India Board and its course may now be approved. The matter was referred to the Southern Regional Committee for examination and recommendation. The Southern Regional Committee appointed an Expert Committee Included the Director of Technical Education, Tamil Nadu. Based on the recommendations of the Southern Regional Committee of the All India Council for Technical Education, the Chairman, AICTE has given approval to the Post-Graduate Diploma in Business Administration awarded by the Loyola Institute of Business Administration to be given from the batch of students admitted in the first year of study during 1990-91, after completion of 3-years part-time study and after passing the required tests and assessments with an intake capacity of 60.(sixty) This approval is given subject to the fulfilment of the following conditions:-

- 1. The Management should shift the Computer Centre to the second floor of the Institute.
- 2. The Management Committee should be constituted in accordance with the guidelines of the AICTE.
- 3. The next meeting of the Management Committee should be held within a year's time.
- 4. The Institute should follow the norms and standards laid down by the AICTE for Post-Graduate Management Programmes.

- 5. The admission should be made on merit as per the guidelines recently issued by the AICTE, and no capitation fee or donation of any kind will be charged for admission.
- 6. The revised AICTE scales of pay must be implemented with immediate effect for the teaching staff of the college.
- 7. The accounts of the institute shall be audited by the chartered accountant and be open for inspection by AICTE or anybody authorised by it.
- 8. The management shall follow strictly any further | deconditions as may be laid down by the AICTE from the to time.
- 2. The visiting Committee of the Southern Regional Committee may satisfy itself after a visit within a year that the conditions have been fulfilled by the Management.
- 3. You are requested to kindly take necessary action in the matter and keep the Southern Regional Committee, Madras and this Council informed of the progress made.
