PROGRAMME OVERVIEW

Since 2005 LIBA has been supervising theses leading to Ph.D. Degree in Business Administration. The PhD Degree programme is affiliated to the University of Madras, Chennai. The Ph.D. programme is offered in disciplines such as marketing, finance, economics, systems, human resource management, decision sciences, operations management and supply chain management and other areas related to management and allied areas of research.

The Institute offers Full Time as well as Part Time Ph.D. Programmes.



CORE OBJECTIVES

- To provide PhD Scholars with supervision of high standard for theses that focus on relevant and innovative areas of research.
- To accompany the PhD Scholars in their formation to become expert in their fields of research.
- To promote an ecosystem of research and publication in the institute.

ELIGIBILITY CRITERIA

Candidates who have completed the following pattern of Study 10+2+3+2 (or) 11+1+3+2 are eligible for admission to Ph.D. Programme.

Candidates should have obtained a Master's Degree with 55% marks in the qualifying examination (PG Degree). For SC/ST candidates and for candidates who have completed the PG degree before 1991, the minimum can be only 50% for admission to the Ph.D. Programme.

The M.Phil. Degree obtained by the candidates through the correspondence / Distance Education / Open University System prior to 3rd April 2009 (date of the Government order) only will be considered as eligible. M.Phil. degree obtained after 3rd April 2009 will not be eligible

Part -time (Internal) Candidate employed other than as a teacher in a permanent job in a registered firm/Institution, within the territorial jurisdiction of the University with a minimum of FOUR YEARS of total working experience, after the qualifying (PG) degree and satisfying the rules framed separately by the syndicate from time to time are eligible to register for Ph.D. (Part-Time) programme.

ADMISSION PROCEDURE

After applying through the University of Madras website (<http://egovernance.unom.ac.in/phd/frmindex.aspx>) candidates have to submit the details to LIBA. Regulations relating to admission / registration, conduct of the programmes, formation of Doctoral Committee, examinations and the award of the degree are framed by the University of Madras and LIBA will follow the same.

Applications are evaluated on the basis of following criteria:

PROGRAMME DURATION

The duration of the programme will be minimum 3 years and maximum 5 years. Exemption of one year from the minimum duration is permissible in the case of candidates with an M.Phil. Degree.
