Action taken from previous year's suggestions:


- In the previous year's meeting, it was suggested to devise mechanisms to enhance student engagement on the topic of sexual harassment. As part of this initiative, posters were displayed in common rooms to encourage student participation and awareness.
- There was a discussion about creating a separate email ID for reporting sexual
 harassment cases within the college premises. However, it was mutually agreed that all
 such cases would be directed to the existing grievances mailbox, and thus the idea of a
 separate mailbox was dropped.


Suggestions for the current year:

- It was suggested that the committee should include representation from the weekend/part-time PGDM students.
- It was also decided that a session on the prevention of sexual harassment would be organized during Vigilance Week.
- A joint initiative with the Centre for Ethics and the Radius Club is planned for the upcoming year to promote awareness about sexual harassment and its prevention.

The meeting of the Internal Complaints Committee (ICC) for Prevention of Sexual Harassment of Women at Workplace was convened to discuss the execution of the committee's responsibilities for the academic year 2024-25

The session commenced with a prayer of Disposition, reflecting the community's gratitude for the well-being of students, faculty, and staff. Prof. B. Aiswarya, the Chairperson of the ICC and Associate Dean of Student and Alumni Relations, initiated the proceedings by introducing the committee members, setting a collaborative tone for the meeting.

A review of the minutes from the previous year's meeting was conducted, providing a foundation for the day's discussions.


